INVITATION FOR BID

1. Sindh Revenue Board (SRB), Government of Sindh, invites sealed bids from interested bidders for carrying out **Interior & Finishing & required civil Works at SRB Newly Acquired Office Space at the 2nd Floor, Northern & Southern Wings and Central Office Space, Shaheen Complex, M.R. Kayani Road, Karachi.**
2. The firms meeting the following criteria are invited to bid;
 - a. Having valid license from Pakistan Engineering Council (PEC) in Category C5 or above with Specialization Code CE10 (copy of the license issued by the PEC required to be submitted with the technical bid).
 - b. At least one similar size interior/finishing civil works (covered area 15,000 Sft) completed during the last 05 years (copy of the completion certificate issued by the client required to be submitted with the technical bid).
 - c. Last three years' average turnover of minimum Rs. 25 Million (Copy of the Audited Financial report required to be submitted with technical bid)
 - d. Registered with FBR/SRB in Income Tax & Sales Tax & enlisted as Active Tax Payer (copy of the registration certificate issued by FBR/SRB required to be submitted with the technical Bid).
3. A complete set of **Bidding Documents** including Post Qualification Document may be obtained from **10th August to 25th August 2020** during office hours (9am to 5pm) the Office of the undersigned on submission of a written application and payment of non-refundable Bidding Document cost Rs. 1,000/- in shape of a pay order/ bank draft in favour of **Sindh Revenue Board, Karachi.**
4. A Pre-Bid Meeting will be held on **13th August 2020** at **1500 hours** at Sindh Revenue Board, Government of Sindh 3rd Floor, Shaheen Complex, M.R. Kayani Road, Karachi.
5. **Single Stage Two-Envelope** procedure will be adopted as per **Rule-46(2) of Sindh Public Procurement (SPP) Rules 2010.**
6. Bid must be accompanied by a **Bid Security amounting to minimum 2% of the Bid Price** in the form specified in the Bidding Documents. Proof of Bid Security to be submitted must be attached with Technical Bids. Bids without Bid Security shall be rejected.
7. Partial, incomplete, conditional bids or bids received after the specified date and time will be rejected. Also, bids submitted through fax, email or telegraph shall not be accepted.
8. Technical Bid & Financial Bid and supporting documents, in separate envelopes, are to be submitted at the office of **undersigned** on **25th August 2020** at **1500 Hours**. The Technical Bid is to be prepared based on information required as per Post Qualification Document and shall be opened at 3rd Floor Shaheen Complex, M.R. Kayani Road Karachi on the same date at **1530 hours** in the presence of the bidders' representative & the Procurement Committee. Bids received after the prescribed time/date shall not be entertained. Financial Bids of only Post Qualified Bidders shall be opened on a date to be communicated later.
9. Procuring Agency reserves the right to reject all or any bids subject at any stage before the award of the contract in accordance with relevant provisions of SPP Rules 2010.
10. In case bids are not opened on the scheduled date due to unscheduled holiday or any other reason, the same shall be opened on the next working day. Other terms and conditions of the bids shall however remain unchanged.
