The Bidders must comply with the following mandatory requirements and required to submit relevant documentary evidences/proof for each requirement:

- The Bidder must be registered with all the relevant authorities and tax entities in its Country of incorporation and required to be registered in Pakistan if the Letter of Award is issued to the Bidder.
- During the past consecutive three (3) years 2016 and onward, the Bidder must have completed two (2) successful implementation contracts involving the development, installation, and provision of technical support for Information Systems of similar functional/technical characteristics and of a comparable scale.
- Average Annual turnover of at least PKR 150 million for the last consecutive three (3) years 2016 and onward.
- The bidder must meet all technical specification defined in Bidding Document
