  - Authorization letter from Original Equipment Manufacturer (OEM), where applicable.

4. The provisions in the Instructions to Bidders and in the General Conditions of Contract are the provisions of the World Bank Standard Bidding Documents: Procurement of Goods for National Competitive Bidding, Pakistan, Part One.
5. The method of procurement shall be under National Competitive Bidding (NCB) procedures specified in the World Bank's *Guidelines: Procurement of Goods, Works and Non-Consulting Services, under IBRD Loans and IDA Credits* January 2011.
