The Sindh Revenue Board (SRB), Government of Sindh has received a loan from the International Development Association (IDA), World Bank, towards the cost of Sindh Public Sector Management Reform Project (SPSMRP), IDA Credit # 5584-PK. It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for “Procurement and Supply of IT Equipment, Licensed Softwares, UPS and Dry Batteries.”

- A. Valid Registration with tax authorities like SRB, FBR.
  - B. Annual turnover of PKR 25 Million and above for the last three years.
  - C. Valid Authorized Dealer Certification of the quoted Brand(s).
  - D. Authorization letter from Original Equipment Manufacturer (OEM) for Notebooks, UPS and Dry Batteries.
  - E. Valid Authorized Partnership Letter of the required brand (s) for Soft wares.

3. The bidders must submit their bids for all the above items or for lot items as mentioned and award shall be on the basis of bidding for each lot of specific items.
4. The provisions in the Instructions to Bidders and in the General Conditions of Contract are the provisions of the World Bank Standard Bidding Documents: Procurement of Goods for National Competitive Bidding, Pakistan, Part One.
5. The method of procurement shall be under National Competitive Bidding (NCB) procedures specified in the World Bank's *Guidelines: Procurement of Goods, Works and Non-Consulting Services, under IBRD Loans and IDA Credits* January 2011.
