



NOTICE INVITING TENDER
PROCUREMENT OF NEXT GENERATION FIREWALL (NGF) AND WEB
APPLICATION FIREWALL (WAF) FOR SRB FOR TWO YEARS

Sindh Revenue Board (SRB) invites sealed bids for next generation firewall and web application firewall with two (2) year subscription and support from well reputed IT firms having registration with FBR, SRB and other relevant authorities.

Eligibility Criteria (Relevant documentary proof shall be required against each criteria):

- Active Tax Payer Certificate from the relevant tax authority.
- Affidavit on the stamp paper from the responsible personnel of the firm that the firm has never been black listed by Government and Semi Government organization/agency/department
- Experienced in supplying and implementing of enterprise level Next-Generation Firewall and Web Application Firewall having at least three (3) successful implementation in corporate environment.
- Average annual turnover of Rs.30 million and above for the last three Financial Years i.e. 2020 onwards (Audited financial statements shall be required)
- The bidder should have mentioned below IT resources with valid experience:
 - Security Engineer for NGF & WAF
 - Project Manager. (Security/ I.T Infrastructure)
- The Bidder and all consortium partners shall not be under a declaration of ineligibility for corrupt or fraudulent practices or blacklisted with any of the Government agencies.
- The bidder should furnish, as part of its bid, Bid Security (BS) of 2% of the Bid Price (The BS should be demonstrated in the Pak rupees and should be in the form of Pay Order/DD/Bank Guarantee).

Complete Bidding Documents can be obtained from 23rd August 2023 to 15th September 2023 during office hours after submitting of Rs 1000/- pay order in favor of "SINDH REVENUE BOARD" from the official address mentioned below.

Bidding process shall be conducted under Single Stage-One envelope bidding procedure described in Sindh Public Procurement (SPP) Rules 2010.

Bids shall contain all the documentary evidences provided in the eligibility criteria.

Schedule of Bidding Process:

- a. The Pre-Bid Meeting to submit the queries regarding the issued Bidding Documents shall be held on Thursday 31st August 2023 at 3pm.
- b. Last Date and Time of submission of Bids: Friday 15th September 2023 by 3.30pm
- c. Date & Time of Opening of Bids: On Friday 15th September 2023 at 4pm
- d. Bids may be submitted at the below mentioned address by hand/or by mail.
- e. Bids shall be opened at the below mentioned address.

Bidding Process shall be conducted as per SPP Rules 2010.
