**ORDER FOR REVOCATION OF SUSPENSION**

Name & NTN of Person Suspended:	M/s Habib and Sons Govt.Contractor And Supplier, SNTN: S1250559-5

Reason for Suspension:	Non-compliance of the provisions of Section 30 of the Sindh Sales Tax on Services Act, 2011 and the rules made thereunder

**BRIEF FACTS OF THE CASE:**

M/s Habib And Sons Govt Contractor and Supplier bearing SNTN: 1250559-5 are registered with SRB under the service category as specified "services provided or rendered by persons engaged in contractual execution of work or furnishing supplies" covered under tariff heading 9809.0000 of the Second Schedule to the Act, 2011 (the "Act, 2011") which are chargeable to the Sindh Sales Tax ("SST") under Section 8 Act, 2011 and rules made thereunder.

02. Scrutiny of the online record of SRB showed that the aforesaid person did not e-file monthly SST returns for tax periods from January-2017 to Jaunary-2019, which was in violation of section 30 of the Act, 2011 and rules made thereunder.

03. Accordingly, a notice was served upon the registered person u/s 25 of SST Act, 2011, read with circular No. 02 of 2013 and rule 10 of SST Act, 2011, whereby the registration of registered person was suspended vide letter No.858 dated: 31-01-2020 for violation of above-mentioned statutory provisions of SST Act, 2011. Moreover, he was required to comply with relevant provisions of SST Act, 2011 and rules made thereunder by e-filing of SST returns for the aforesaid tax periods, failing which the case was to further proceed for cancellation of registration.

04. The registered person, vide letter No. Nil received in this office on 10-01-2024, requested for revocation of suspension as they intend to apply / participate in tenders and want to commence their economic activity and paid penalty amount of Rs.40,000 vide CPR No. S120240110-0105-1186494 dated:10.01.2024 and CPR No.S1-20240126-0105-1602961 dated 26.01.2024. The registered person realized the mistake and committed to e-filing all sales tax returns as required under section 30 of the Act, 2011.
