**ORDER FOR PROVISIONAL REVOCATION OF SUSPENSION**

Name & SNTN of Person Suspended:	<b>M/S. Dynamic Power Construction (SNTN: 5426534-2)</b>

Reason for Suspension	Non-compliance of the provision of section 8, 17 & 30 of the Sindh Sales Tax on Services Act, 2011 and the rules made thereunder
Tax Periods:	January 2021 to December 2023

Whereas, M/S. Dynamic Power Construction are registered with Sindh Revenue Board having SNTN: 5426534-2, are engaged in providing or rendering taxable services of “Construction Services” classified under tariff heading 9824.0000 of the Second Schedule of the Sindh Sales Tax on Services Act, 2011 (referred as “Act, 2011”).

2. Scrutiny of tax profile of M/s. Dynamic Power Construction revealed that they had failed to deposit Sindh sales tax on services amounting to Rs.13,549,420/-for the tax periods from January 2021 to December 2023 , in manner as prescribed in section 9 and Section 17 of the Act, 2011 read with rule 14 of the Rules, 2011. The person has also failed to comply with section 9 and section 17 of the Act, 2011 read with the relevant provision of the Rules, 2011.

3. Accordingly, order of suspension of the registration bearing reference No. SRB-COM-IV/UNIT-03/2024/372746 dated 18<sup>th</sup> April, 2024 was served upon the registered person under section 25 of the Act, 2011 read with Circular No.02 of 2013 and Rule 10 of the Rules, 2011 whereby the registration of. M/s. Dynamic Power Construction was suspended against the non-payment of SST and wrong-filing of SST returns from (Jun January 2021 to December 2023).

4. Vide letter dated 24<sup>th</sup> April, 2024 M/s. Dynamic Power Construction, made following submissions:-

“We, M/S Dynamic Power Construction bearing SNTN Number S5426534-2 in Sindh Revenue Board (SRB) were issued an Order of Suspension from SRB on April 18, 2024, reference number **No. SRB-COM-IV/UNIT-03/2024/372746** against the non-payment of Sindh Sales Tax (SST) amounting to Rupees 13,549,420/- for the tax period from January 2021 to December 2023.

In compliance to order **No. SRB-COM-IV/UNIT-03/2024/37274** Dated: April 18, 2024, we have deposited Sindh Sales Tax (SST) amounting to Rupees 7,272,765/- vide details are as below

2. CPR# S1-20240420-0105-1427706, Tax Period 09/2022, Amount: Rupees 844,201/-

4. Tax Period 10/23, Amount Rupees 306,744/- (Deposit Slips Attached)
5. Tax Period 11/23, Amount Rupees 1,314,433/- (Deposit Slips Attached)
6. Tax Period 06/23, Amount Rupees 797,853/- (Deposit Slips Attached)
7. Tax Period 03/22, Amount Rupees 2,833,786/- (Deposit Slips Attached)

Further, Remaining Amount Rupees 6,276,655/-, which is unpaid and will be paid in two installments i.e. First Installment Amount Rupees 3,000,000/- will be paid till May 15, 2024 and Second Installment Amount Rupees 3,276,655/- will be paid till June 15, 2024. Current Month tax liabilities will be paid monthly without any delay.

Sindh Revenue Board (SRB) has the right to take any legal action against the company and deponent of the affidavit for any deviation of the commitments.

We therefore request you for immediate revocation of our company's registration so we may continue the business smoothly and pay our tax liabilities accordingly"

5. Furthermore, R/P has submitted post-dated of remaining liability along with affidavit wherein they have assured to comply with statutory requirements of the law. Therefore, taking a lenient view and for purpose of carrying on their business activity as well as subsequent remedial actions to be taken by the registered person, the suspension of the registered person is hereby **revoked with immediate effect**. In case, if taxpayer fails to comply any of the above stated remedial actions and to their undertaking, the registration of taxpayer shall be subject to suspension without further notice.

6. Registered person is also advised in his own interest to immediately e-file true and correct monthly Sindh Sales Tax Returns and deposit the Sindh Sales Tax over and above in terms of sections 8, 9, 17 and 30 of the Act-2011 read with Rule 11,12,13 and 14 of the Rules-2011 along with default surcharge under section 44 and penalties listed under serial No.3 of the table appended to section 43 of the Act, 2011 failing which necessary action including imposition of penalties and re-suspension of their registration shall be initiated as per law. Please note that the returns filed by the registered person will be subject to assessment under the relevant provisions of the Act-2011.
