The pending cases, including the cases in which any notice, hearing notice or show-cause notice was issued by an officer of the SRB in exercise of the powers under the notification No.SRB-3-4/28/2022 dated 5th August, 2022, and all other notifications/ amendments issued in relation thereto, shall stand transferred to the respective officer of the SRB having jurisdiction under this notification.

4. This notification is issued in supersession of the notification No.SRB-3-4/28/2022 dated 5th August, 2022 and shall take effect immediately.
