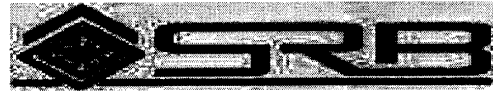

ORDER FOR WITHDRAWAL OF SUSPENSION

Brief Description	Non-compliance of the provisions of section 30 of Sindh Sales Tax on Services Act, 2011 and rules made thereunder.

BRIEF FACTS OF THE CASE:

M/s. Asadullah Shaikh Govt: Contractor & Order Supplier (hereinafter “the Registered Person”), bearing SNTN No.3255741-8, is registered for Sindh Sales Tax on Services under the service category of “Contractor of building (including water supply, gas supply and sanitary works), electrical and mechanical works (including air conditioning), multi-disciplinary works (including turn-key projects) and similar other works” (tariff heading 9824.2000). The persons registered for Sindh Sales Tax on Services under section 24, 24A or 24B are required to e-file true and correct monthly Sindh sales tax returns under section 30 of the Sindh Sales Tax on Services Act, 2011 (hereinafter “the Act, 2011”) and the rules made thereunder, for the tax period by the 18th day of the month following the tax period to which it relates respectively.

2. Scrutiny of the online record of SRB showed that the registered person failed to e-file monthly Sindh sales tax returns for the tax periods from **March, 2017, April, 2017, May, 2017 and June, 2017**, which was in violation of section 30 of the Act, 2011 and rules made thereunder.

3. Accordingly, a notice was served upon the registered person u/s 25 of the Act, 2011, read with circular No. 02 of 2013 and rules made thereunder, whereby the registration of the registered person was suspended vide this office Notice NO.SRB-COM-II/DC-13/Suspension Order/01/17-18/239571 dated 25-07-2017 for violation of above-mentioned statutory provision of the Act, 2011. Moreover, he was required to comply with relevant provisions of the Act, 2011 and rules made thereunder by e-filing of Sindh sales tax returns, and deposit the

due Sindh sales tax amount (if any) for the relevant tax periods, failing which the case was to further proceed for cancellation of registration.

4. The registered person on 04.09.2024 attended the office along with the written request. He informed that he was not aware of his obligation of filing return on monthly basis. In addition, he also clarified that he did not do any economic activity during that period nor any work was awarded to him. He emphatically requested that he is a poor person and was badly affected with flood in Sindh at that time. He did not know that if no economic activity is carried out then returns are still liable to be filed. He humbly requested for consideration on activation of registration.

5. In view of above, the case is considered lawfully for revocation of suspension. Further, undersigned in terms of notification No.SRB-3-4/27/2023 dated 08.06.2023 sought approval lawfully for revocation of suspension by the concerned Commissioner (Hyderabad), SRB.

6. In view of the foregoing position, it is requested that the SRB registration of M/s Asadullah Shaikh Govt: Contractor & Order Supplier, bearing SNTN: 3255741-8, may be restored with immediate effect, under intimation to the undersigned, so that the taxpayer may be able to file his due Sindh sales tax returns and pay the due Sindh sales tax amount if any.

7. M/s Asadullah Shaikh Govt: Contractor & Order Supplier, bearing SNTN 3255741-8 are required to immediately e-file their monthly sales tax returns and deposit the due Sindh sales tax amount (if any) for the relevant tax periods after restoration of their suspended registration.
