**ORDER FOR DEREGISTRATION OF M/S. ECKO ASIAN AGENCIES(SNTN: S0613657-5)
CUSTOM HOUSE AGENCY LICENSE NO. 365**

M/s. Ecko Asian Agencies bearing SNTN#: S0613657-5 are registered with SRB in the service category of 'Customs Agents' classified vide tariff heading 9805.4000 of the Second Schedule to the Sindh Sales Tax on Services Act, 2011 'Act-2011' since 6th September, 2012. The services provided or rendered by the registered person are chargeable to SST at the rate of 13% respectively under section 3, 8, 9, 17 and 30 of the Act-2011 read with relevant rules made thereunder of the Sindh Sales Tax on Services Rule, 2011 (hereinafter referred to as 'Rules-2011').

2. Whereas, **M/s. Ecko Asian Agencies** 'registered person' vide SST Form-02 applied for de-registration application received to SRB dated 21st February, 2023 wherein they have selected reason for de-registration as **ceased to carry on business**.

3. The registered person vide their letter No. **SAS-325/2023** dated 28th August, 2023 submitted that *Custom House Agency License has not been transferred to anyone. It has been surrendered for furnishing the services of Clearing and Forwarding vide letter dated 2nd May, 2016 and also submits that their WEBOC/PSW has been disabled by the Custom House due to non-functional/non-activities.*


4. Thereafter, submissions of the registered person were evaluated and information in this regard was sought from Government of Pakistan, Collectorate of Customs Appraisalment-West, Customs House, Karachi which was acquired vide letter No. **APPG./LA/SI/MISC/6/71(P-1)** dated 21st September, 2023 wherein it was informed that **"The license of Ms Ecko Asian Agencies (CHAL No. 365) issued in the name of Mr. Haroon Farooqui, was surrendered by the licensee in 2016 vide their request dated 2nd May, 2016 and the Licensing Authority on 11th May, 2016 cancelled the license."**

5. Subsequently, acceding to their request made vide SST Form-02 and relevant information obtained from Government of Pakistan, Collectorate of Customs Appraisalment-West, Customs House, Karachi adequately substantiate their stated reason for de-registration.

6. In view of the above stated facts, I order for deregistration of **M/s. Ecko Asian Agencies** bearing SNTN#: S0613657 from the tariff heading 9805.4000 of the second schedule to the Act-2011 in terms of section 25A of the Act-2011 read with rule 9 of the Rules-2011 with the mandatory

obligation for the registered person who shall be liable for SST liability as enumerated in the section 22 of the Act *ibid*.


